1) CALL TO ORDER/REVIEW MINUTES

- a) Call to Order
 - i) The meeting was called to order at 1:15 p.m.
- b) Review of August 28, 2018 Minutes
 - i) The minutes of the previous meeting were reviewed and approved.

2) OLD BUSINESS

- a) Enrollment Update (Academic/Student Affairs)
 - i) Fall enrollment looks strong for LRSC. Head count should close, up about ten students and FTE should also close, up about ten students.
- b) Student Services: Open Position update (Academic/Student Affairs)
 - i) The full time Student Service/Financial Aid employee position has been offered and accepted by Merissa Halvorson.
- c) Weight Room Progress (Suggestion Box)
 - i) VP Halvorson reported that Director Mertens has been collecting estimates for a new treadmill, two exercise bikes, and various repairs to the existing equipment.

3) NEW BUSINESS

- a) Governors Visit (President's Office)
 - i) Jace Beehler from Governor Burgum's office has scheduled October 4th as the date the Governor will visit Lake Region State College. Council discussed how the meeting can be structured and who should be brought into discussions.
- b) 2018-19 Committee List (President's Office) (see list attached below)
- c) Graduate Credits/Degree Stipends (Academic/Student Affairs)
 - i) Director Driessen would like to put together a package to assist dual credit instructors with their faculty qualifications plan or offer a stipend for becoming qualified. Create a list of dual credit instructors' faculty qualifications list.
- d) **CATYC Conference** (Academic/Student Affairs)
 - i) Every September, CATYC (Council on Accreditation for Two-Year Colleges) hosts a fall conference for professional development and networking to promote quality standards and practices for accreditation and that support the goals of The Higher Learning Commission. CATYC is the second largest organization for two-year colleges and is comprised of the nineteen states accredited by the Higher Learning Commission. VP Halvorson attended the conference September 9-11 in Branson, Missouri. Federal government



regulations like Title IV, Gainful Employment, State Authorization for Distance Ed, and Student Defense are being re-examined.

e) Administrative Affairs Report

- i) VP Kenner reported the System Office asked for a detailed report of what LRSC would do with the \$1,000,000. VP Kenner asked council members to compile a list of one-time expenditure ideas.
- ii) CCF Auditors will be on campus Monday, September 17th.

f) Cabinet Conference Call

i) President Darling stated the Chancellor has requested campuses report on faculty turnover since the budget cut were implemented.

g) Academic and Student Affairs Report

- i) HR Manager Lillehaugen and Director Nelson are collecting cost estimates for the upgrades to the Business Wing of the college. Physical Plant wants to put the carpet in some of the rooms in the business wing before Christmas break, so they can also take vacations during that time. Classes will be relocated where possible.
- ii) Surplus property in Bismarck will not take our surplus auction items. LRSC will have to find storage until items can be sold.
